

# Sustainability Returning Grantee Application Groups, FY 2024

Beginning in FY 2024, the OAC’s Sustainability program will follow a staggered, multi-year review process. Grants will continue to be four years in duration, but deadlines will now be offered every two years; half of the applicant pool will apply at the first two-year deadline, the other half will apply at the next two-year deadline. New applicants to the program may apply at either deadline. Applicants will continue to be reviewed separately within budget groups with like-sized applicants as either Sustainability-Large, Sustainability-Mid-Sized, and now Sustainability-Small (replacing Arts Access) organizations. Please review the [Guidelines 2024-2025](#) for further details, including deadline information and submission requirements for each budget grouping.

Existing grantees – that is, organizations funded via Sustainability or Arts Access in FY 2023 – have been assigned to two groups, A and B. Group A organizations are required to submit full “on-year” applications by February 1, 2023, for FY 2024 funding (and again in 2027 and every four years thereafter). Group B organizations are required to submit “off-year” updates by April 1, 2023, for FY 2024 and again by April 1, 2024, for FY 2025 funding, thus extending their awards and using panel scores from their last operating support panel review in award calculations. Group B organizations will then be required to submit full “on-year” applications by February 1, 2025, for FY 2026 funding (and again in 2029 and every four years thereafter). Final Reports will continue to be due each year at the conclusion of each grant award for all grantees. Any applicant turned down for Sustainability support at its regular on-year deadline may apply again two years later.

Both on-year applications and off-year updates will continue to be submitted via ARTIE. In ARTIE, off-year updates will continue to be opened only for affected organizations as in the past (Group B, for FY 2024). **Please make sure your organization is preparing the correct type of application – on-year or off-year – as you begin your work in the ARTIE system.** Contact your program coordinator with any questions.
